License/Registration/Permit Ordinance

Ordinance # 6

The Town Board of Athelstane, Marinette County, Wisconsin does hereby ordain as follows:

Section 1 – Title/Purpose

This ordinance is entitled the “Town of Athelstane General Licenses/Registration/Permits Ordinance.” The purpose of this ordinance is as follows:

Section 2 – Authority

The Town Board of Athelstane has the specific statutory authority, powers and duties, pursuant to the specific statutory sections noted in this ordinance and/or by its adoption of village powers under Sec.60.10 (1988-1989) Wis. Stats., to regulate, control, license, register or permit in the Town of Athelstane persons engaged in certain uses, activities, businesses and operations at certain locations in the Town of Athelstane, to assess these persons with appropriate fees for the licenses, registrations or permits as noted herein and to enforce, by revocation or penalty, the provisions of these ordinances and the provisions of the licenses, registrations and permits.

Section 3 – Adoption of ordinance

The Town Board of Athelstane has, by adoption of this ordinance, confirmed the specific statutory authority, powers and duties noted in the specific sections of this ordinance and has established by these sections and this ordinance to regulate and control persons engaged in certain uses, activities, businesses and operations at certain locations within the Town of Athelstane, to assess these persons with appropriate fees for licenses, registrations or permits and to enforce, by revocation or penalty, the provisions of these ordinances and the provisions of the licenses, registrations and permits.

Section 4 – General provisions

Fees /Penalties

The Town Board of Athelstane has, by this ordinance, required and confirmed the following licenses, registrations or permits and the Town Board of Athelstane has, for the period of July 1st to June 30th of each year established that the following will be the fees to be paid by any person to the Town of Athelstane for the noted licenses, noted registrations or noted permits and the following will be the penalties to be paid by any person to the Town of Athelstane for violations of these ordinances and the violations of the license, registration and permit conditions:

1. Cigarette License

a. License	\$5.00
b. Penalty for violation	\$25.00

2. Intoxicating Liquor

a. Class A /Class B (Beer)	\$25.00
b. Class A Liquor	\$50.00
c. Class B Liquor	\$125.00
d. Operators License (bartender)	\$5.00

3. Building Permit

a. Permit	\$40.00
b. Penalty for violation – failure to obtain permit	\$200.00

4. Billboard Permit

a. Permit	\$10.00

b. Penalty for violation:

failure to obtain permit up to \$100.00

5. Culvert / Driveway

a. Permit \$25.00

b. Penalty for Violation

failure to obtain permit up to \$150.00

6. Dog / Cat

a. Permit for spayed or neutered \$3.00

b .for not spayed or neutered \$8.00

c. kennel fee for multiple dogs/cats \$35.00

b. Penalty for violation -

for obtaining license after April 1st \$5.00

7. Firemen Park Rental \$50.00

8. Town Hall Rental \$40.00

All nonprofit organizations are exempt from fee – all others are required to pay the rental fee and sign an agreement obtained from the Town Clerk.

9. Fire Number \$50.00

a. duplication/ replacement of Fire number \$40.00

10. Variance

\$150.00

a. plus the actual cost of notification and publication.

11. Utility Application/ Permit

\$50.00

General License and Permit Ordinance Provisions

No persons shall engage or allow on land owned, used or leased by that person in the Town of Athelstane any particular use, activity, business or operation until that person has obtained the required license, registration or permit as established by the Town of Athelstane in this ordinance.

To the extent permitted by law, the Town may apply to a court of competent jurisdiction for an injunction preventing further or continuing violations of this ordinance.
